ORDER SETTING STATUS HEARING

THIS MATTER comes before Patrick Schaefer, Hearing Examiner for the New Mexico Public Regulation Commission ("Commission"), upon the Hearing Examiner's own motion. Being duly informed, the Hearing Examiner FINDS and CONCLUDES that:

- On October 28, 2025, New Mexico Governor Michelle Lujan Grisham issued
 Executive Order No. 2025-373, declaring a state of emergency due to the ongoing
 impairment of water service provided by Melody Ranch Water Company, LLC
 ("Melody Ranch"). The Executive Order was issued the day after the Torrance County
 Commission declared a state of emergency regarding the service disruption at Melody
 Ranch, on October 27, 2025.
- 2. Commission Utility Division Staff ("Staff") then filed, on October 30, 2025, an unopposed emergency motion ¹ seeking to suspend Melody Ranch's currently-operative commodity charge, effective November 1, 2025, pending any future order from the Commission; and to direct Melody Ranch to immediately dispatch its personnel to gauge the production from the existing well as well as the amount of water currently in its storage tank. There, Staff stated that the Executive Order requires the Commission to consider the implications of the Anti-donation Clause of the New

Mexico Constitution, which operates as a general prohibition against providing state aid or donations for the benefit of private actors without receiving consideration in exchange. Therefore, Staff, in its motion, urged the Commission to suspend the commodity charge effective November 1, 2025. Melody Ranch did not oppose the motion.

3. On October 30, 2025, the Commission granted Staff's request, ordering the suspension of Melody Ranch's currently operative commodity charge, effective immediately.² The Commission also ordered that Melody Ranch shall immediately dispatch its personnel to gauge the production from the existing well for the purpose of calculating its customers' commodity charges for the current billing period.

It is therefore **ORDERED** that a status hearing will be held beginning at 9 a.m. on Thursday, December 4, 2025. The conference will be held via the Zoom videoconferencing platform. An invitation to the Zoom videoconference shall be sent by separate e-mail to all persons on the accompanying service list.
