ORDER VACATING STATUS CONFERENCE OF JANUARY 28

Schaefer, Hearing Examiner for the New Mexico Public Regulation Commission (“Commission”), upon the above-captioned matter involving Melody Ranch Water Company, LLC, and the Commission’s Order Appointing Hearing Examiner and Order to Show Cause, issued on August 21, 2025.

Being duly informed, the Hearing Examiner **FINDS** and **CONCLUDES**:

1. On December 23, 2025, the Hearing Examiner filed an Order Amending Status Conference Schedule, and ordered that scheduled status conferences, in which the Hearing Examiner and parties attend, shall be held beginning at 9 a.m. on Wednesday, December 31, 2025; January 7, 2026; January 28, 2026; and February 11, 2026.

A. The status conference currently scheduled for January 28, 2026, is hereby **VACATED**.

B. The next scheduled status conference in this matter shall proceed at 9 a.m. on Wednesday, February 11, 2026, via the Zoom videoconferencing platform.
