My name is Ray Collins. I have lived in the Melody Ranch subdivision for over 21 years. I am responding to the PRC's September 18th staff status report. The fact this has been allowed to go on for this long is mindboggling, but what is worse is to read the following statement in the report "In the short term, lower water demand during the winter provides some relief, but the risk of freezing pipes from reduced flow levels remains a concern." The damage will be caused by direct negligence of Melody Ranch Water co and to some degree every office that has allowed this problem to persist. We would like an answer to this question.
