## **INTERIM STATUS REPORT**

The Utility Division Staff ("Staff") of the New Mexico Public Regulation Commission (the "Commission") provides this interim status report in the interest of providing, at the earliest opportunity, all available and relevant data responsive to the December 9, 2025, Order Setting Status Conference Schedule and Report Deadlines. Staff respectfully submits the following:

- The hearing examiner's December 9, 2025, order directed Staff to file a report providing the historical averages of water usage at Melody Ranch for October and November, the actual water usage for October and November 2025, and an estimated timeline of how long the emergency funds provided by the state will last, taking into account both past and current monthly usage rates.
- Although Staff requested and the hearing examiner granted an extension of time until next Friday, December 19, 2025, to respond in full to the December 9, 2025, order, Staff is able today to provide a partial response. The following data has been obtained from Melody Ranch by Staff on various occasions, as identified in the accompanying footnotes.
- The following is the actual monthly water usage at Melody Ranch over the past six years:<sup>2</sup>

- (4) Based on the above numbers,<sup>3</sup> Melody Ranch's five-year historical average water usage (between 2020 and 2024) for the month of October is 338,576 gallons. The same average for the month of November is 293,399 gallons.
- (5) The following is Melody Ranch's total annual water sales (in gallons), according to its annual reports:<sup>4</sup>

However, this data is not contained in this status report because, in providing the October and November usage data outlined above, Melody Ranch explained that it had just become aware that these previous figures may have been inaccurate in that they represented well production rather than actual water usage.

Melody Ranch estimates that its well pump produces water at a rate of 4.7 gallons per

minute, or 202,000 gallons per month.<sup>5</sup>

The water tankers currently serving Melody Ranch (paid for by the state) have a volume

of 4,000 gallons each at a cost of approximately \$265.6

In a previous email estimating the cost of water hauling, Melody Ranch estimated that it

would require deliveries of approximately 100,000 to 150,000 gallons per month to provide full,

uninterrupted service to customers. Based on the cost for each water tanker, this would cost

approximately \$6,625 to \$9,937.50 per month.

(9) The final item requested by the hearing examiner's December 9, 2025, order was an

estimated timeline of how long the emergency funds provided by the state will last. A meaningful

and reliable estimate, however, will require more than the October and November usage data

previously outlined. Specifically, Staff has determined that it will need to obtain the past 36 months

of actual water usage at Melody Ranch in order to be confident in its estimate.<sup>7</sup>

(10) Lastly, in the interest of full disclosure, the Commission should be aware that, on or about

Tuesday, December 9, 2025, Staff was notified that several Melody Ranch customers were

experiencing low water pressure. Melody Ranch thereafter determined that a water pump was in

need of repair. It is reported that the pump was successfully repaired and reinstalled on Thursday,

December 11, 2025, and full pressure was restored to all customers on that date.
