NOTICE OF SCHEDULED WORKSHOP

On August 10, 2023, the Commission opened an inquiry into the factors that the Public Service Company of New Mexico ("PNM") and El Paso Electric Company ("EPE") should consider when determining whether to participate in a regional day-ahead market ("DAM") or regional transmission organization ("RTO")1. The Commission held the initial workshop on September 21, 2023. The subsequent workshop was held on January 25, 2024. The third workshop is set to occur on May 17, 2023, at 12:30 pm.

This workshop will include presentations by the California Independent System Operator ("CAISO") and Southwest Power Pool ("SPP") discussing an overview and an update of their respective DAMs. CAISO and SPP should include the following in their presentations:

- i. Overview of their respective DAM
- ii. Status of the DAM, tariff development, FERC approval, and applicable timeline
- iii. Current utility commitments to the DAM
- Proposed method(s) of greenhouse gas emission tracking of resources purchased in v. the DAM
- vi. Governance structure of the DAM
- vii. Costs of utility participation in the DAM
