ORDER ESTABLISHING REVISED PROCEDURAL SCHEDULE

THIS MATTER comes before John F. Kreienkamp and Patrick Schaefer, hearing examiners for the New Mexico Public Regulation Commission, upon their own motion. The hearing examiners **FIND** and **CONCLUDE** as follows:

1. On April 10, 2025, the hearing examiners entered an order that, among other requirements, directed Petitioner and Staff to confer with one another regarding the establishment of a revised procedural schedule.¹ The same order also provided that, if necessary, a prehearing conference could be held.

2. At Staff's request,² the hearing examiners entered another order setting a prehearing conference to occur on April 23, 2025.³

3. Shortly prior to the prehearing conference, counsel for Petitioner e-mailed the hearing examiners and service list stating that the parties had discussed and agreed to a procedural schedule.

4. The prehearing conference was conducted as scheduled and was attended by counsel for Petitioner and Staff. The procedural schedule proposed by the parties and discussed

during the prehearing conference should be and is approved as ordered below.

It is therefore **ORDERED**:

- A. Staff shall file direct testimony by **Monday, May 12, 2025**.
- B. Rebuttal testimony may be filed by either party by **Wednesday, May 21, 2025**.
- C. A stipulation may be filed at any time prior to the close of business on **Wednesday, May 28, 2025**.
- D. Any motions *in limine*, motions to strike testimony, or other prehearing motions shall be filed on or before the close of business on **Monday, June 9, 2025**. Responses to such motions shall be filed on or before the close of business on **Monday, June 16, 2025**.
- E. On or before the close of business on **Monday, June 16, 2025**, and after Petitioner confers with Staff, the Company shall e-mail the hearing examiners and service list a proposed order of examination of witnesses.
- F. A prehearing conference is tentatively scheduled for **Tuesday, June 17, 2025**, commencing at 9:00 a.m. Mountain Time on the Zoom videoconference platform. The purpose of the conference is to address, if necessary and among other items, prehearing matters and any other matters that may expedite the orderly conduct and disposition of this proceeding. The conference may be vacated if deemed unnecessary by the hearing examiner.
- G. The public evidentiary hearing shall commence on **Friday, June 20, 2025**, beginning at 9:00 a.m. MT. The hearing shall be transcribed by a court reporter, and the transcript shall be available in the normal course. The hearing will be held via the Zoom videoconferencing platform. Access to and participation in the public evidentiary hearing will be limited to party-participants (i.e., counsel and witnesses), the Commissioners, and other essential Commission personnel. The Zoom hearing will be livestreamed through YouTube and a link to the stream will

be posted on the Commission's website at <https://www.prc.nm.gov/public-hearings/>. Persons not participating in the evidentiary hearing as an attorney or witness may view the hearing on YouTube and shall not join the hearing via Zoom except to provide oral comment as allowed below.

H. Oral public comments will be permitted at the commencement of the public hearing. Any person interested in providing public comment must contact Ana Kippenbrock, with the Hearing Examiners Division, at Ana.Kippenbrock@prc.nm.gov or (505) 690-4191 by no later than the close of business on **Wednesday, June 18, 2025**. Public comments will be limited to three minutes per speaker.

I. Except as expressly provided by this order, all provisions of the procedural order⁴ issued on December 15, 2023, remain in full force and effect.
